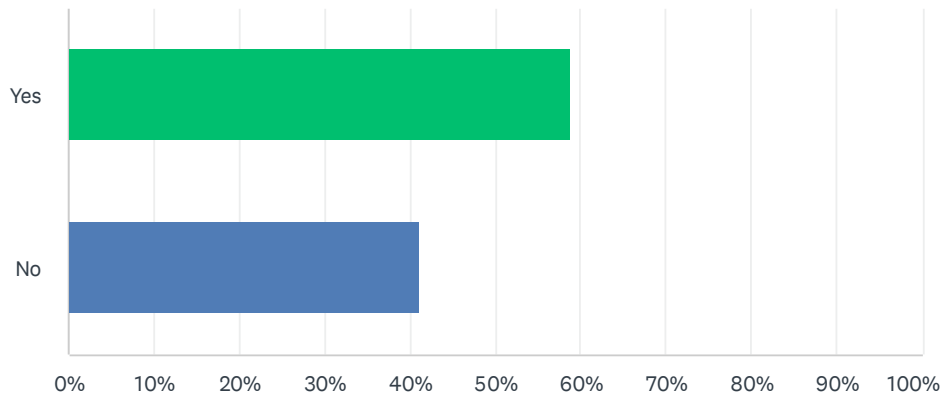


Q1 Do you live in the Broads? If yes, go to question 2. If no, go to question 7.

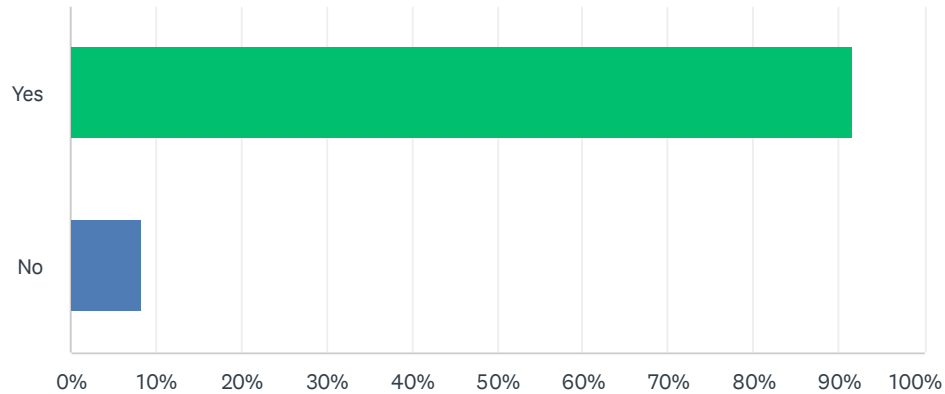

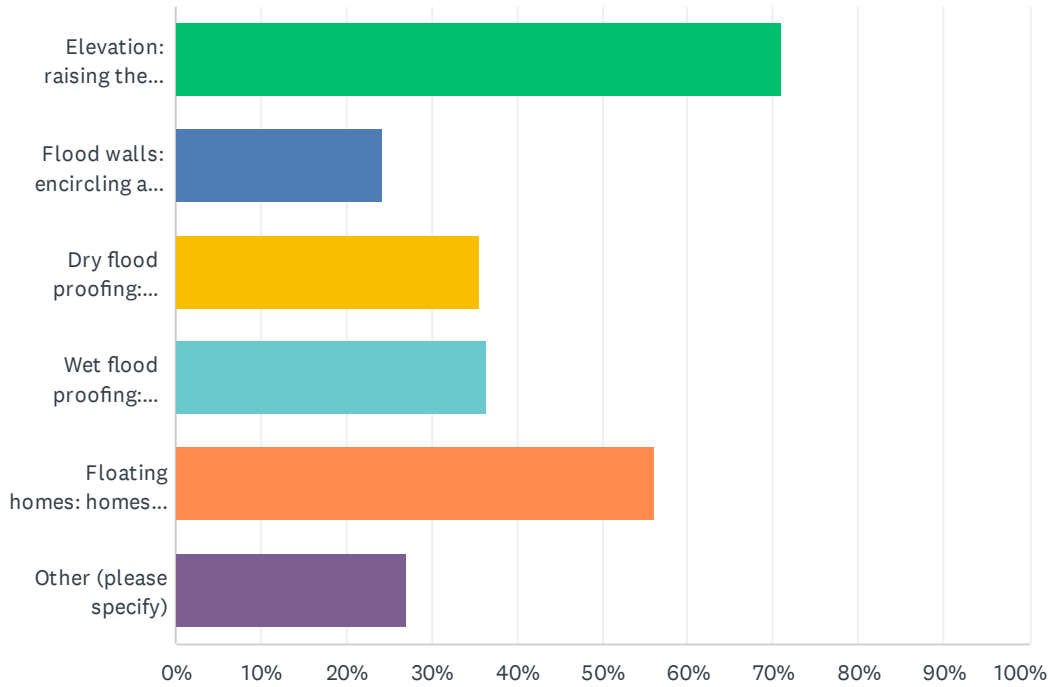

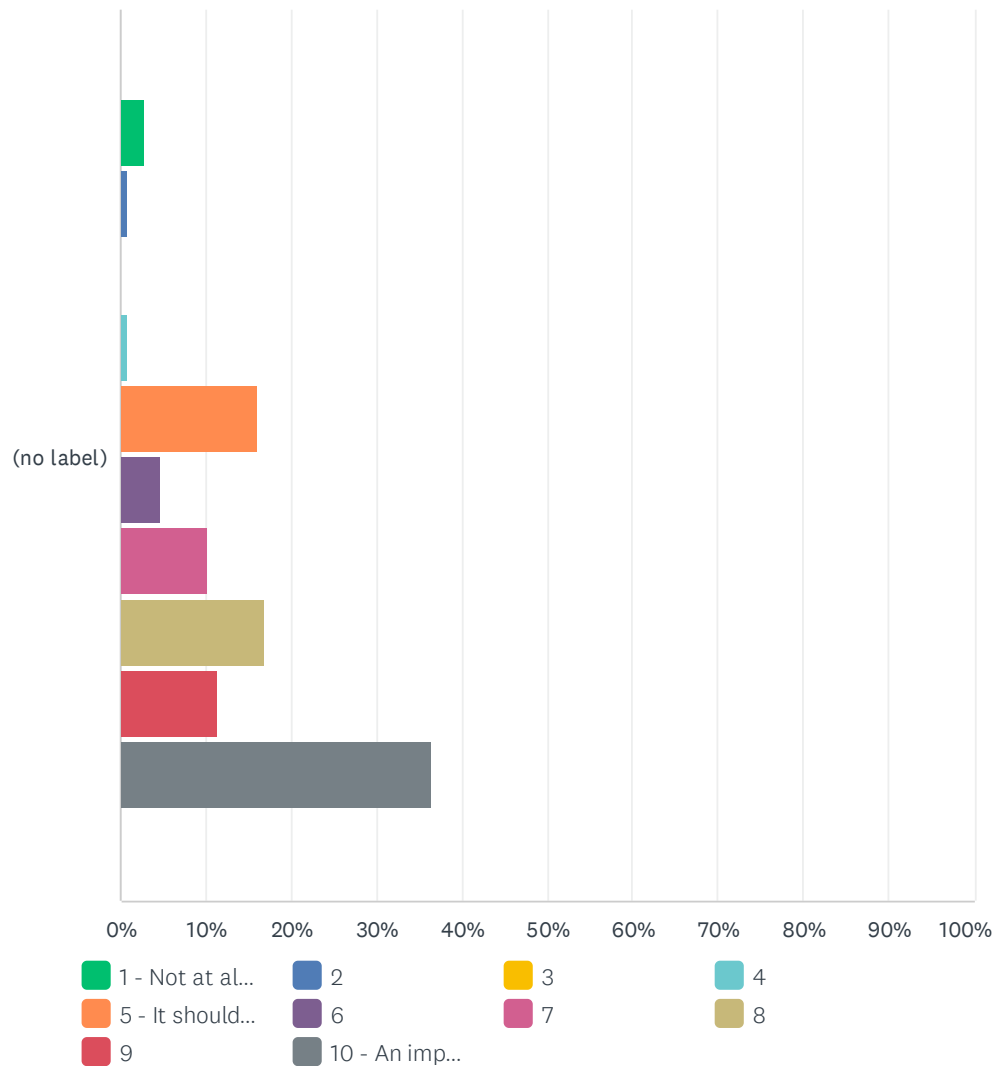
