

Register of Interests form

As a member of the Broads Authority, these are the interests which you are required to register with the Authority by section 30 of the [Localism Act 2011](#).

Register of interests must be declared:

- **within 28 days of becoming a member; and**
- **within 28 days of becoming aware of any new interest, or of any change to a registered interest.**

Failure to register or disclose a disclosable pecuniary interest is a criminal offence under the Localism Act 2011.

Where you have a **'sensitive interest'** you must notify the Monitoring Officer with the reasons why you believe it is a sensitive interest. If the Monitoring Officer agrees, they will withhold the interest from the public register. A 'sensitive interest' is as an interest which, if disclosed, could lead to the member, or a person connected with the member, being subject to violence or intimidation.

'Disclosable Pecuniary Interest' means an interest of yourself or of your partner if you are aware of your partner's interest.

'Partner' means a spouse or civil partner, or a person with whom you are living as husband or wife, or a person with whom you are living as if you are civil partners.

Contracts	Any contract made between the member or his/her spouse or civil partner or the person with whom the member is living as if they were spouses/civil partners (or a firm in which such person is a partner, or an incorporated body of which such person is a director or a body that such person has a beneficial interest in the securities of) and the Authority (a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged.	n/a
Land and property	Any beneficial interest in land which is within the area of the Authority.	n/a

Licenses	Any licence (alone or jointly with others) to occupy land in the area of the Authority for a month or longer.	n/a
Corporate tenancies	Any tenancy where (to the member's knowledge) (a) The landlord is the Authority; and (b) The tenant is a body that the member, or his/her partner is a partner of or a director of or has a beneficial interest in the securities of.	n/a
Securities	Any beneficial interest in securities of a body where (a) That body (to the member's knowledge) has a place of business or land in the area of the Authority; and (b) Either i. The total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or ii.
