

# Register of Interests form

As a member of the Broads Authority, these are the interests which you are required to register with the Authority by section 30 of the [Localism Act 2011](#).

**Register of interests must be declared:**

- **within 28 days of becoming a member; and**
- **within 28 days of becoming aware of any new interest, or of any change to a registered interest.**

**Failure to register or disclose a disclosable pecuniary interest is a criminal offence under the Localism Act 2011.**

Where you have a **'sensitive interest'** you must notify the Monitoring Officer with the reasons why you believe it is a sensitive interest. If the Monitoring Officer agrees, they will withhold the interest from the public register. A 'sensitive interest' is an interest which, if disclosed, could lead to the member, or a person connected with the member, being subject to violence or intimidation.

**'Disclosable Pecuniary Interest'** means an interest of yourself or of your partner if you are aware of your partner's interest.

**'Partner'** means a spouse or civil partner, or a person with whom you are living as husband or wife, or a person with whom you are living as if you are civil partners.
