1 Introduction

- 1.1 The attached table at Appendix 1 shows an update of the position on appeals to the Secretary of State against the Authority since October 2012. It lists those appeals where decisions have been received in the last month and have yet to be made.
- 1.2 The attached schedule at Appendix 2 shows a summary of the decisions by the Secretary of State on appeals in the last year since April 2012.
- 1.3 Between 1 April 2012 and 31 March 2013 the Authority has received decisions on fourteen appeals, although seven of these had been registered before April 2012. Eleven of the appeal decisions related to decisions made by officers under delegated powers while two appeals were against enforcement. Appeals Received

Since 1 April 2012, the Authority has received 10 Appeals (to 31 March 2013). Decisions have been received on seven of these. Seven of these appeals on which the Secretary of State has made a decision were appeals against refusal of planning permission. Of these, five were dismissed and two allowed. The remaining Decisions on three appeals received since October 2012 are outstanding, although it must be noted that two of these have only been received since January 2013.
