#### **Chief Executive's Report**

#### Summary:

This report summarises the current position in respect of a number of important projects and events, including any decisions taken during the recent cycle of committee meetings. It does not include matters which are already on the agenda for this meeting. Members are asked to note the report.

# 1 The Promotion and Marketing of the Broads

Contact Officer/Broads Plan Objective: John Packman/Nil

- 1.1 At its meeting on 12 July 2013, the Authority received a report providing an update on the funding of the new promotion and marketing post established from 1 July 2013 including an update on recent discussions with the Hire Boat Industry and visits to boatyards by ten members of the Authority as well as a very positive meeting with Hoseasons. It was noted that there was general support for the Authority continuing to have a role in promoting and marketing the Broads in partnership with Broads Tourism. However, the boating organisations took a different view from the Authority's Solicitor as to the funding of that role on whether the activity could be part funded from navigation expenditure. Members had also received a paper endorsed by the BMF, BHBF, RYA and NSBA and circulated by Mr Ollier on the arrangements for the apportionment of expenditure and "Why it would be unlawful for the Broads Authority to use 'Navigation income' to contribute to these costs."
- 1.2 Members noted the two options outlined for consideration for the funding of the cost of the post outside the STEP programme entirely from National Park Grant or on the basis of 70% NPG and 30% (£13,500) navigation expenditure. The message from Broads Tourism and the hire boat operators was that the Authority should be doing a lot more to promote tourism in the Broads especially as this was of great value to the local economy. Therefore the post now had a greater emphasis on marketing and was placed in the Communications team where its activities crossed over all the Authority's duties. As the hire boat industry which contributed to navigation expenditure, was a significant beneficiary of the area of work being undertaken by the new post, the option of considering whether a contribution should be made from navigation income had been put forward and supported by the Navigation Committee subject to the legal constraints being clarified.
- 1.3 As the amount suggested to come from navigation funds was relatively small, the Authority agreed to fund this year's promotion and marketing activity, outside the STEP programme, amounting to £45,000, entirely from National Park Grant, adjusting the budget accordingly and await the outcome of the

Comprehensive Spending Review before determining the way forward for 2014/15.

- 1.4 As a follow up from the various discussions with the hire boat industry and Broads Tourism, members agreed that the Chairs of the Authority and Navigation Committee, the Chief Executive and Collector of Tolls should follow up the issues raised during those visits with the Broads Hire Boat Federation.
- 1.5 Following a suggestion from a member that the Authority find out more of the opinions of its customers, focusing on toll payers, in a similar way to the way Hoseasons and other private businesses had done, the Authority agreed to conduct a sample survey of toll payers, residents and others to gain a better insight of the private boat owners who use the Broads and others with an interest in the Broads and their opinions; this would be funded 50% from navigation expenditure and 50% from National Park Grant. This would supplement and extend the Authority's annual toll payers' survey, usually funded 100% from navigation income.
- Strategic Priorities 2013/14
  Contact Officer/Broads Plan Objective: John Packman/Multiple
- 2.1 The Authority's strategic priorities relating to the Management of the Navigation Area and Moorings are detailed at Appendix 1, together with the action taken to date and their current status. All key projects are currently green with the exception of the award of the Hydrographic survey contract in priority 2(c)1. Though the award of this contract has been delayed until September, there is no major cause for concern.
- 3 Implications of the Breydon Water Hydromorphic and Engineering Study Contact Officer/Broads Plan Objective: Dan Hoare/NA1 and NA4
- 3.1 At its meeting on 12 July 2013, the Authority received a report and gave consideration to the JBA Consulting Study on the localized, short term impacts arising from the modelled management options of the historic training wall structures in Breydon Water including an assessment of the sediment dynamics. The Navigation Committee had the opportunity to consider the options at its meeting on 6 June and their deliberations were included within the report.
- 3.2 The Authority accepted the Navigation Committee's recommendations. It was agreed that the Turn-tide Jetty be retained in its current form for the medium term, providing appropriate navigational safety marks, with regular surveys and monitoring determining the future maintenance works required to keep the structure safe whilst allowing the final 40m to degrade in the long term. It was also agreed that the current navigation safety marks with regard to the Dickey Works be maintained and the remaining timber work be allowed to slowly degrade in situ but by the end of October 2013 a basic structural investigation be undertaken to enable a better evaluation of the most cost

effective option to balance this with navigational safety of slow degradation or complete removal.

3.3 The Authority also agreed that a 2m recreational navigation depth should be targeted and that the existing navigation channel of Breydon Water was adequate with strategic positioning of marker posts in order to minimize dredging requirements whilst maintaining a clearly defined passage across Breydon, but that further work be carried out as to the options and costs. It was also noted that any proposals to increase the dredging depth to 4m would need to take account of Habitat Regulations and the impact on the conservation interests of the area.

#### 4 Deal Ground Planning Application Update Contact Officer/Broads Plan Objective: Andrea Long/Nil

4.1 Outline Planning permission for a mixed development of 670 dwellings, a local centre comprising commercial uses, restaurant, dining quarter, public house and commercial units was granted by Norwich City Council in July 2013. The application had been the subject of the consultation with the Broads Authority at Navigation Committee and planning committee in April. The key concerns raise by the Broads Authority included provision of moorings within the development and also the relationship of the development with the bridge application which was considered by the Broads Authority Committee in August 2013 and approved subject to confirmation of no objection from Network Rail. Following the comments made by the Broads Authority on the Deal Ground application some amendments were made to the scheme to accommodate on line mooring provision although details are still to be fully worked out. Both applications are outline in nature and therefore separate future applications will be required for reserved matters both of which will need to be considered by future Broads Authority Navigation and Planning Committees.

## 5 Charges for Rowing Craft

Contact Officer/Broads Plan Objective: John Packman/Nil

5.1 A meeting was held on 15 August 2013 to discuss charges for rowing craft. Officers suggested that a parallel arrangement to that in place for sailing and canoeing could be considered to reduce the navigation charges for rowing craft used by young people. This was welcomed by the representatives of the rowing clubs and will be worked up as a proposal for inclusion in the main tolls report for consideration at the October meeting.

#### 6 Payment of Tolls by the Hire Boat Fleet Contact Officer/Broads Plan Objective: John Packman/Nil

6.1 The Authority's officers have had a productive meeting with representatives of the Broads Hire Boat Federation concerning the payment schedule for next year's tolls. The meeting explored the annual pattern of income to the hire boat yards and the administrative demands on the Authority of extra payments. The fine detail of the outline proposals needs further investigation

by the Authority's officers and wider consultation with the BHBF Members and is set out below for the Committee's information.

- 1. Total bills for an individual yard below £2,500 will be required to be paid in one sum by 1 April.
- 2. Total bills for an individual yard between £2,500 and £7,500 will be eligible for the arrangement of two equal payments on 1 April to 1 July.
- 3. Bills for yards paid by Hoseasons will be paid for simplicity and reduced administration in one payment by 1 April.
- 4. For yards that are members of the British Marine Federation **or** the Broads Hire Boat Federation and have total bills greater than £7,500 an option to make four payments in the following manner will be available:

1 April	10%
31 May	30%
30 June	30%
31 July	30%

#### 7 Broads Blog

- 7.1 Navigation Committee members represented concern that the monthly Bulletin provides a less effective medium for those with a particular interest with what is happening on the water than the old weekly note from Broads Control.

#### 8 Mutford Lock Update

Contact Officer/Broads Plan Objectives: Angie Leeper/TR1.6

8.1 At the members request a briefing note regarding Mutford Lock was prepared and presented to committee in June 2013. Officers have investigated and sought further clarification from Suffolk County Council relating to the obligation to operate the bridge. There is no primary legislation specific to the bridge but there are general powers to build or re-build bridges in the Highways Act 1980 but the authority, for these particular bridges, derives from a Bridge Scheme under S106 of the Act. Whilst not secondary legislation in the sense of a Statutory Instrument, the authority given was for lifting bridges. The solicitors will add appropriate wording to the tripartite agreement to ensure that there is no doubt regarding the responsibility of the operation of the bridge in future years.

8.2 NP Law confirm that the Harbour Revision Order is now agreed between the two parties and will be submitted in draft to the Marine Management Organisation by week ending 5 September for their comments and once they are happy will be formally submitted.

#### 9 Navigation Patrolling and Performance Targets

Contact Officer/Broads Plan Objective: Adrian Vernon/NA4.3

- 9.1 The figures for May to the end of July reflect the busier season and the better weather. The rangers have had to deal with a number of incidents involving drunken youths in day boats and all male stag parties. Both navigation and public order offences are being investigated by the rangers and the police and prosecutions will follow where possible. The record for each month of the percentage of time spent by ranger teams in their integrated navigation and countryside duties is shown in Appendix 2
- 9.2 Two cases were dealt with at Magistrates Court in June as shown in Appendix 3.
