Hearing dates

The Secretary of State has appointed **Ms Katie Child BSc (Hons) MA MRTPI** of the Planning Inspectorate to conduct the Examination. The hearings will commence on Monday 2 July and will run for two weeks between **2-6 July** and **16-19 July**. Sessions will be held at the Broads Authority's head office at Yare House. Please note that there is no parking on site, but public car parks are situated nearby.

The Inspector has issued **guidance to participants** on the procedural and administrative arrangements for the examination, together with a draft **hearings programme**. These are attached to this email.

Matters, Issues and Questions (MIQs)

I also attach the Inspector's **Matters, Issues and Questions (MIQs)**. These will form the core of the discussion at the hearing sessions. Anyone who has made representations may submit hearing statements on the MIQs. You may, if you prefer, rely on your previous submission.

Hearing statements must be received by 5pm on Friday 15 June.

Attending the examination hearings

If you wish to appear at the hearing sessions, please confirm your attendance by 5pm on Friday 15 June.

Only those who have previously made representations relevant to the matters being discussed and are seeking to change the Plan have a right to participate at the hearing sessions. However, the sessions are open for anyone to observe. Can you also let me know if you wish to withdraw your representation.
