Annual Report of the Local Access Forum

Summary: Since its inception in 2003 the Local Access Forum has, in accordance with the relevant government regulations, submitted a report to the annual meeting of the Broads Authority setting out its activities in the year. 1 Requirement to Produce an Annual Report

1.1 Since its inception in 2003 the Local Access Forum has submitted a report to the annual meeting of the Broads Authority setting out its activities during the year. The relevant section of the recent Guidance sets out the statutory requirement as follows:

"Regulation 13 requires every forum to produce an annual report on the discharge of its functions. The report should set out the main issues and occasions on which the forum has given advice during the year, and indicate the bodies to whom advice was given. The report may also:

- review how effective the forum was in meeting its own criteria for measuring success or effectiveness and completing its forward work programme;
- identify the forum members and the interests they represent;
- give information on the meetings held and the main issues discussed;
- give information on any training events held;
- summarise any feedback received from section 94(4) bodies;
- identify issues which posed a particular challenge for the forum; and
- address other issues relevant to the work of the forum."
- 1.2 The Regulations require the appointing authority to:
 - (a) publish the annual report, and
 - (b) send a copy to the Natural England within 21 days of publication. (This information will be used to assist Natural England in delivering its own functions, and in supporting forums (e.g. through training)).

1. Broads Local Access Forum

1.1 Statutory purpose

The Broads Local Access Forum is an independent advisory body established by the Broads Authority in 2003, under the Countryside and Rights of Way Act 2000. The Act states that the purpose of the forum is to be a statutory advisory body to provide guidance and advice to the Broads Authority and other organisations on the improvement of public access within the Broads and to contribute to opportunities for open air recreation and the enjoyment of the area. In providing advice, the forum will have regard to

- The needs of land management.
- The conservation of the natural beauty of the area.
- The management and maintenance of recreational access whilst balancing this against the needs of nature conservation, agriculture, the interests of landowners and managers, navigation and countryside management projects within the Broads.

1.2 The forum's vision

The Broads is an unrivalled wetland of natural diversity, heritage and special character. It is a place where people come to explore, enjoy and find spiritual refreshment. Access to the Broads should be clear and easy to use, respectful of wildlife and land management, meet users' needs and promote responsible and harmonious behaviour. The Broads Local Access Forum will champion access improvements and management, represent a wide range of interests and contribute to sustainability for environment, communities and the economy.

2. What has happened during the year?

2.1 The forum at work

The forum has delivered its purpose in a number of ways:

- i. The forum has held three public meetings to agree its advice to the Broads Authority and other organisations.
- ii. The forum provides representation on the Broads Forum and the Norfolk Local Access Forum.
- iii. Forum members provide advice by individual correspondence on consultation documents.
- iv. The Chair and Vice Chair attended the East of England Local Access Forum Chairs and Vice Chairs' meeting to consider and better understand areas of common concern and ways of partnership working in the eastern region.

v. Forum members are expected to use and develop their own networks of contacts to gather information and opinion, and to offer advice and information on access.

2.2 Challenges faced by the forum

The forum faced the following challenges:

- The reduction of funding for maintenance of rights of way by local authorities generally.
- The withdrawal of funding for access agreements in agri-environment schemes.
- The reduction in support from Natural England.

The forum has given advice on the following issues:

- Finalising the content of the Broads Integrated Access Strategy.
- Paths for Communities.
- Broads Outdoors Festival.

2.4 Responding to consultations

The forum has responded to the following consultations:
