## Supplementary Question submitted by Mr J Campbell

Mr Campbell asked a supplementary question concerning the view the Committee took on spending large amounts of public money on a broad with little or no public access and how that sat with the aim of the Authority to become a national park.

## **Response to Supplementary Question**

Dear Mr Campbell,

From your attendance at the Navigation Committee meeting you will know that members did provide comments during their consideration of the Hoveton Great Broad agenda item which were relative to your supplementary question. Some members made comments on the right of navigation, wanting the scheme to have more access for all; this substantiates the members' views over the desire for more public access for the scheme. These Navigation Committee's views were also represented during the Broads Authority meeting on 26 September 2014, when the Broads Authority considered whether to support Natural England's applications for external funding for the proposed project.

During the Broads Authority meeting, members recognised the major contribution that the Hoveton Great Broad Restoration Project would provide in the delivery of objectives for the Authority's Biodiversity and Water Strategy. However, the Broads Authority was also cognisant of the views of the Navigation Committee and indeed supported that the project should also be able to achieve better public access to the project area to meet one of the Broads Authority's purposes: promoting opportunities for the understanding and enjoyment of the special qualities of the Broads by the public. The Broads Authority therefore supported Natural England's application for external funding conditional on the achievement of better public access to the project area. This conditional support will encourage Natural England to achieve better public access to the project area with the landowner and we look forward to receiving the outcome of such engagement.

As previously advised, the Navigation Committee will return to the issue concerning the "Legal Position of Broads Closed to Navigation" at a future meeting, to allow members to have a full understanding of the issues. It is hoped that this will be included on the agenda for the meeting on 23 October 2014.

It is regrettable that you have found the responses to your questions unsatisfactory, but you are very welcome to listen to the continuing debate on the issue concerning the legality of closed broads at the next meeting of the Navigation Committee should you wish to or, of course, to pose any further written questions that you might wish to ask in order to explore the issue.
