Chief Executive's Report

Summary: This report summarises the current position in respect of a number of important projects and events, including any decisions taken during the recent cycle of committee meetings. It does not include matters which are already on the agenda for this meeting of the Committee. In two incidences decisions were taken by the Broads Authority which were not in accordance with the recommendations of the Navigation Committee; under these circumstances the Authority is required to report back to the Committee on the reasons for its decisions. Members are asked to note the report.

1 Breydon Water and Water Ski Designation Contact Officer/Broads Plan Objective: Andrea Long

- 1.1 As the report for the Broads Authority was being compiled on the designation of a water skiing zone on Breydon Water, further information was supplied on the presence of significant populations of avocets and black-tailed godwits using the estuary in the summer months. Furthermore, there was not existing evidence of disturbance to birds in the winter months. As a result of this the Authority amended the proposal from that considered by the Navigation Committee on 11 October such that the Authority will be consulting on:
 - (1) The establishment of a trial waterskiing zone for the purpose of monitoring the impact on the designated features of the Special Protection Area in line with the provisions of the Habitats Directive.
 - (2) The designation of the trial zone will be for a **minimum** of one year **and all the year round** so that monitoring can be undertaken for the 12 months cycle:
 - (3) The activity that will form the trial will encompass all aspects of water skiing as permitted in the Broads including wake boarding and "getting air".

2 Navigation Charges 2012/13

- 2.1 The Authority considered the report of the Tolls Working Group and the recommendations of the Navigation Committee when setting the navigation charges for 2012/13. The Authority adopted the recommendations of the Committee in respect of:
 - (1) Adopting the Guiding Principles and Criteria recommended by the Tolls Working Group and endorsed by the Navigation Committee.

- (2) Reducing the charges for 7-day visit tolls from 70% to 50% of the 14 day toll as an incentive to visiting craft.
- (3) Reducing the charges for a smaller private boat of 5 square metres from £97.44 to £90.00 to narrow the gap in charges with powered boats of the same size and that the charges for all other private boats be in line with Scenario 2 of Table 3 on page 9 of 29 in the report.
- (4) Reducing the current multipliers to 2.65 and 2.95 for weekly hired and passenger boats respectively.
- (5) Ferries are charged at the private rate toll.
- (6) Further consideration should be given to charges for rowing craft and a discounting arrangement for boats visiting the Broads through Mutford Lock.
- 2.2 When it came to considering the level of overall toll income the Authority decided that it should be raised by 3% rather than the 1.5% proposed by the Navigation Committee.
- 2.3 All members recognised that the Authority still faces big challenges, especially dredging the rivers and broads and maintaining its assets, including 4km of public moorings. This followed a report and presentation on the Authority's Asset Strategy which is on this meeting's agenda.
- 2.4 Members opposing the lower increase were concerned that a 1.5% increase next year might be followed by a bigger increase the following year and it was better to smooth out the changes and they considered that the prior adoption of a financial strategy planning a year by year increase of 3% was more important. Other arguments in support were that it was not always a sound idea to seek compromise but to make difficult decisions and that the hire boat industry enjoyed tax relief on their payments. Prudent provision of reserve funds for asset replacement would mean larger sums would be needed than had previously been provided for, and the loss of Tolls income over the three years of the Financial Strategy would lead to a funding gap of around £130,000. The whole thrust of financial information presented to the meeting argued strongly for a 3% rise rather than 1.5%.
- 2.5 Members who supported the 1.5% increase made the point that all of these arguments had been fully considered and asked for recognition of the current hardship and economic uncertainty and the way in which the budget had been underspent in previous years. The measures were a complete package that had been agreed and should not be separated. Increases in subsequent years could be considered when the economic situation was clearer and the monies so far collected fully spent.
- 2.6 The vote was a finely balanced outcome with 8 to 7 against the resolution proposed by the Chairman of the Navigation Committee for a recommended 1.5% which would result in the Authority, as it would normally do, accepting

the Navigation Committee's recommendation. A subsequent proposition in support of the 3% increase in Tolls was carried by 9 votes to 6.

2.7 Members noted the recommendation of the Tolls Working Group, supported by the Navigation Committee, that the Hire Boat Multiplier should be considered by the Navigation Committee each year, recognised the complexity of this issue as difficult to resolve, and accepted that this was a matter upon which there needed to be further consideration.

3 Breydon Water Practical Works and Modelling

Contact Officer/Broads Plan Objective: Trudi Wakelin/NA4.1

- 3.1 Since the last report, works have been completed to improve the channel marking at Bure Mouth. This has involved the removal of the 'crooked' yellow post, as well as three additional post's stumps which were found by the diving contractor and the installation of a new yellow special mark along with new starboard marks to reduce the opportunity for craft to cut the corner.
- 3.2 Additionally, the contract for the hydrographic modelling study of Breydon Water has now been let to JBA consulting in association with Deltares. Work is ongoing to collect and collate the necessary data currently, with modelling and options development to take place in the new year.

4 **Review of Consultative Arrangements**

Contact Officer/Broads Plan Objective: Andrea Long/None

4.1 At its meeting of the 22 November 2012, the Broads Forum considered a number of suggestions to improve the overall efficiency and effectiveness of the Forum. Forum members had been canvassed for their own ideas at their July meeting and many had attended the facilitated workshop with consultants held on the 3 October 2012. Forum members agreed a number of changes to the operation of the Forum and these include – election of chairman from within the Forum membership, standing agenda item for parish issues, measures to increase communication between Forum members and nominating groups, wider publicity for Forum members to promote the work of the Forum, support for a better balance of agenda items between discussion and information items and between items suggested by Forum members and those raised by the Broads Authority. However Forum members did not support the establishment of an "on-line" discussion forum. The comments of the Forum will be fed back to the Member Working Group looking at the Review of Consultative Arrangements and it is hoped that the Broads Authority will given the go-ahead for the changes at its meeting in January 2013. Broads Forum members would then be able to consider a revised Terms of Reference at their next planned meeting in February 2013.

5 Strategic Priorities 2012/13

Contact Officer/Broads Plan Objective: John Packman/Multiple

5.1 The Authority's strategic priorities relating to the Management of the Navigation Area and Moorings are detailed at Appendix 1, together with the

action taken to date and their current status. The traffic lights for all key projects are currently green with the exception of:

- (a) Priority 2(c)1: Timetable slipped slightly, but report on this agenda.
- (b) Priority 3(b)2/3: The public consultation for the Integrated Access Strategy has been slightly delayed, but will commence in November. Presentation on this agenda.
- (c) Priority 4.1: A delayed start date for the development of the Dockyard has meant that the completion dates for this priority is likely to slip. This traffic light is currently yellow.

6 Navigation Patrolling and Performance Targets

Contact Officer/Broads Plan Objective: Adrian Vernon/NA4.3

6.1 The Rangers Exercise of Powers Analysis is now complete for the summer season and considerable activity can be seen. Staff sickness had a bearing on best value in some areas late in the season but this has now been resolved. Speeding in Wroxham and the Upper Bure continues to be a problem although as most offenders are dayboat helmsman it is easily dealt with by verbal and blue book warnings. To tackle this problem in future road type lighted signs, voluntary lower governing of dayboat engine speeds, encouraging yard owners to fit GPS instruments and the use of a new technology, namely long distance video binoculars, are all being considered.

7 Sunken and Abandoned Vessel Update

7.1 One long term sunken vessel in the Thorpe Old River has finally been raised by the owner thereby saving the Authority both time and money. A further vessel has sunk at the top end of the cut and it is hoped that all three vessels in the area will be removed by crane once permission has been granted by Network Rail. It is also hoped that following a forthcoming site meeting and discussions that Network Rail will take more serious steps to prevent further trespass mooring in the future.

8 Planning Enforcement Update
